- 1. Call to Order at 1730 by Commissioner Shafer
- 2. Roll Call of Commissioners present: Commissioner Brenning, Commissioner Clarkson, Commissioner Gridley, Commissioner Olmstead, Commissioner Shafer
- 3. Pledge of Allegiance led by Commissioner Shafer
- 4. Motion to conduct an Oath of Office for Marvin Olmstead as a CJFD Fire Commissioner for the 3-yr period from 1/1/2025 to 12/31/2027 by Commissioner Gridley and seconded by Commissioner Clarkson. All in favor. Motion carried. Chairman Shafer then administered the Oath of Office for Commissioner Olmstead.
